POSTDOCTORAL FELLOWSHIP IN WOMEN'S HEALTH AND INTERVENTION DEVELOPMENT

The research lab of Dr. James W Griffith is seeking a postdoctoral fellow to join a project to develop an intervention for underserved women with pelvic floor disorders. The project is co-led by three Multiple Principal Investigators: Dr. Griffith (Associate Professor and clinical psychologist), Dr. Kim Kenton (Chief of Female Pelvic Medicine and Reconstructive Surgery), and Dr. Melissa Simon (Director - Center for Health Equity Transformation; Vice Chair for Research, Department of Obstetrics and Gynecology). The postdoctoral fellow will primarily work on an R01-funded project, but there are opportunities to work on and develop other projects depending on the trainee's interests and availability of funding.

The postdoctoral fellow will contribute to research activities including protocol development, writing scientific manuscripts, presenting at conferences, and mentoring of junior lab members. Dr. Griffith will be the primary mentor of the fellow, but they will have opportunities to collaborate with other faculty throughout Northwestern University. Dr. Griffith's lab focuses on enhancing clinical assessment and intervention; the lab website provides a synopsis of current team members and projects: https://sites.northwestern.edu/griffithlab/.

Eligibility: Completion of doctoral degree is preferred prior to the start of the position, but candidates who have completed all requirements except their dissertation will be considered. The candidate should have a doctoral degree related to clinical research, such as clinical psychology, health services, etc. Experience in multidisciplinary research will support a successful application. Other preferred (but not necessarily required) attributes would be experience with clinical interventions, Spanish language proficiency, and/or experience with clinical and/or qualitative interviewing.
